- 1.1. The ASSAM ELECTRICITY GRID CORPORATION LIMITED, ("the Employer") invites sealed bids from eligible bidders for "**Supply of EHV GRADE TRANSFORMER OIL**".
- 1.2. The brief description of scope of Works covered under this Bidding Document is furnished below:
 - a) Manufacture of 100(Hundred) KL of New EHV Grade of Transformer Oil and all testing at manufacturer's works, supply and delivery at substation site with all accessories, mandatory spares & special tools/kits unloading at sites.
 - b) Packing in non-returnable drums and supply & delivery at designated destination (s) including loading at manufacturer's works and unloading at designated site.

1.3 Eligible Bidders

Subject to the fulfilling the Qualifying Criteria (as per Appendix-2 of this Section), a Bidder may be a firm or company. When the bidder is a firm, the names and address of the partners should be indicated and a copy of the certificate of registration with the concerned Registrar of firms should be enclosed with the Bid.

When the bidder is a Company, the company registration document along with Memorandum of Association should be submitted

- 3.0 [To gain time for preparation of their Bids, intending bidders may also inspect or download the Bidding Document by visiting the website, www.aegcl.co.in or <https://aeqcl.etenders.in>. However, for participation in bidding procedure, a bidder must compulsorily pay the tender fee. The bidders should also note that only the bidders who have submitted tender fee will be invited for participation in pre-bid meeting]
- 4.0 Though, viewing & downloading of the bid document is free of cost, for participation in bidding procedure bidder has to pay a non – refundable tender fee of **INR 5,000.00** only through e-tendering portal.

5.0 Qualification of the Bidder

- 5.1. To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in Appendix to ITB-2, Section-1 of the Bidding Document.
- 5.2. Before purchasing of the Bidding Document, the interested Bidders may visit the office of the Managing Director or the web site of Assam Electricity Grid Corporation Ltd. (www.aegcl.co.in).

6.0 Submission of Bids

- 6.1. All bids must be submitted in accordance with the instructions to the Bidders on or before **12:00 Hours on 07.07.2017** and the technical proposals will be opened in the portal.
- 6.2. All bids must be accompanied by a bid security amounting to **Rs. 1, 80, 000.00** in the form of Bank Guarantee. Bid security shall have to be valid for **30 days beyond the validity of Bid**.

- 6.3. Scanned copy of the bid security BG in PDF format must be uploaded as part of techno-commercial bid. However, the bid security BG in original shall have to be submitted to the office of the Managing Director, 1(one) hour prior to bid opening.
- 6.4. AEGCL will not be responsible for any costs or expenses incurred on the preparation or delivery of the Bids.

7.0 Opening of Bids

- 7.1. AEGCL reserves the right to cancel/withdraw the invitation for Bids without assigning any reason & shall bear no liability whatsoever consequent upon such a decision.
- 7.2. Only those bidders whose Technical Bid is found substantially responsive and acceptable to the requirements of the Bidding Documents shall be considered for opening of Price Bid (price proposal). The date and time of opening of Price Bid shall be communicated to those bidders whose bids are qualified for opening.

8.0 SPECIAL NOTE TO BIDDERS :

- 8.1. Bidder must create user ID in the web portal <https://aegcl.etenders.in> in order to participate in the e-tender.
- 8.2. A Bidder will be required to Encrypt and Sign online bid using their own Digital Signature Certificate (Class-II or higher with both Signing and Encryption Certificates). Prospective Bidders must procure DSC before participating in the tenders or in order to login into the portal.
- 8.3. A Bidder must download the Bidding Documents from the mentioned portal and both Technical & Price bid must be submitted through **online mode only** along with all scanned copy supporting documents (suggested scan at 150 dpi in PDF with a file size upto 10MB). The documents should be duly signed, scanned and uploaded with proper name. However, AEGCL may ask bidder to submit hard copies of GTP, Drawing, Manufacturer authorization of the major items and any other documents if deemed necessary.
- 8.4. A Bidder will be required to pay a **Non-Refundable Service Fee** (Online only) in order to participate in the bidding process.
- 8.5. Service provider/AEGCL will not be responsible for misplacement/delay in receipt of either request for e-bidding OR instrument copy sent by post.
- 8.6. Bidder can Re-work/Edit their bids before closing date of the tender. Bidders are advised to submit/re-work their bids well advance in time to avoid any last minute unforeseen hassle.
