1.0 The ASSAM ELECTRICITY GRID CORPORATION LIMITED, (“the Purchaser”) invites **online bids** (Through E-tendering portal) from eligible bidders for “**Supply of Diagnostic Tools and Related Services for Various Substations of AEGCL under PSDF-B**”.

1.1. Bidders shall be required to bid for the complete Package and no part offer shall be accepted.

1.2. The brief description of scope of Works covered under this Bidding Document is furnished below:

- (i) Design, manufacture, testing at manufacturer’s works and supply of various Diagnostic Tools with all fittings, accessories and necessary spare including transportation and delivery at designated sites.
- (ii) Installation Testing and Commissioning of the Diagnostic Tools at designated locations with all the materials required for completion of the works by deputation of suitable personnel for demonstration and hands-on training of AEGCL personnel at designated sites.

However, for participation in bidding procedure, a bidder must compulsorily pay the tender fee. The bidders should also note that only the bidders who have submitted tender fee will be invited for participation in pre-bid meeting]

3.0 Though, viewing & downloading of the bid document is free of cost, for participation in bidding procedure bidder has to pay a non – refundable tender fee of **INR 5,000.00** in the form of DD/Banker’s Cheque in favour of Managing Director, AEGCL, Bijulee Bhawan, Paltanbazar payable at Guwahati.

4.0 For E-tendering, a ‘**Single Stage Two-Envelope**’ bidding procedure will be adopted comprising of 1) Techno-commercial bid and 2) Price bid. Both the bids must be submitted online through e-tendering portal <https://assamtenders.gov.in>. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive to the requirements Bidding Document will be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document shall be opened on a date notified in due course of time.

5.0 Qualification of the Bidder

5.1 To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in Appendix to ITB-2, Section-1 of the Bidding Document.

5.2 The interested Bidders are advised to visit the office of the Managing Director or the web site mentioned above to know these criteria.

6.0 Submission of Bids

- 6.1 All bids must be submitted in accordance with the instructions to the Bidders on or before **12:00 Hours on 03 . 12 .2017** and the technical proposals will be opened in the portal at **14:00 Hrs on 05 . 12 .2017**.
- 6.2 All bids must be accompanied by a bid security amounting to **Rs. 10,00,000.00(Ten Lakhs only)** in the form of Bank Guarantee. Bid security shall have to be valid for **30 days beyond the validity of Bid**.
- 6.3 Scanned copy of the bid security BG in PDF format must be uploaded as part of techno-commercial bid. However, the bid security BG in original shall have to be submitted to the office of the Managing Director, 1(one) hour prior to bid submission deadline.
- 6.4 AEGCL will not be responsible for any costs or expenses incurred on the preparation or submission of the Bids.

7.0 Opening of Bids

- 7.1 AEGCL reserves the right to cancel/withdraw the invitation for Bids without assigning any reason & shall bear no liability whatsoever consequent upon such a decision.
- 7.2 Only those bidders whose Technical Bid is found substantially responsive and acceptable to the requirements of the Bidding Documents shall be considered for opening of Price Bid (price proposal). The date and time of opening of Price Bid shall be communicated to those bidders whose bids are qualified for opening.

8.0 SPECIAL NOTE TO BIDDERS :

- 8.1 Bidder must create user ID in the web portal <https://assamtenders.gov.in> in order to participate in the e-tender.
- 8.2 The participating bidders should have valid Digital Signature Certificate (DSC) and have to register in the portal <https://assamtenders.gov.in>.
- 8.3 For other information regarding bid submission, bidders may refer to the Assam Government e-procurement portal <https://assamtenders.gov.in>.
- 8.4 A Bidder must download the Bidding Documents from the mentioned portal and both Technical & Price bid must be submitted through **online mode only** along with all scanned copy supporting documents. The documents should be duly signed, scanned and **uploaded with meaningful name**. However, AEGCL may ask bidder to submit hard copies of GTP, Drawing, Manufacturer authorization of the major items and any other documents if deemed necessary.

9.0 All the corrigendum/addendum will only be published on <https://assamtenders.gov.in> and www.aegcl.co.in . Bidders are advised to regularly visit the sites for any updates.

- 10.0 AEGCL is not bound to accept the offer of lowest bidder. The undersigned reserves the right to accept or reject any or all the bids without assigning any reason thereof.
