- 1.0 The ASSAM ELECTRICITY GRID CORPORATION LIMITED, ("the Purchaser") invites online bids (Through E-tendering portal)from eligible bidders for "Construction of Kiosk Building within switchyard with all necessary services at various substations of AEGCL-C".
- 1.1. Bidders shall be required to bid for the complete Package(s) and no part offer shall be accepted.
- 1.2. The brief description of scope of Works covered under this Bidding Document is furnished below:

Construction of RCC Kiosk Buildings at various substations of AEGCL complete with all finishes including air condition, electrification, construction of cable trenches inside the building, Earthing arrangement of Kiosk etc. as per this section and drawings and also the outdoor cable trenches to link the Kiosk to the existing cable trenches as per drawings and specification including all materials and labour to complete the job.

- 3.0 Though, viewing & downloading of the bid document is free of cost, for participation in bidding procedure bidder has to pay a non refundable tender fee of INR 5,000.00 only though e-tendering portal.
- 4.0 For E-tendering, a 'Single Stage Two-Envelope' bidding procedure will be adopted comprising of 1) Techno-commercial bid and 2) Price bid. Both the bids must be submitted online through e-tendering portal <a href="https://aegcl.etenders.in">https://aegcl.etenders.in</a>. Technical proposals which are submitted by non-qualified bidders or which are not substantially responsive to the requirements Bidding Document will be rejected. The price proposals of only those Bidders, whose technical proposals are found responsive to the requirements of the Bidding Document shall be opened on a date notified in due course of time.

#### 5.0 Qualification of the Bidder

- 5.1 To be qualified for award of Contract, bidders must compulsorily meet each of the criteria in the area of experience, financial position etc. as described in Appendix to ITB-2, Section-1 of the Bidding Document.
- 5.2 The interested Bidders are advised to visit the office of the Managing Director or the web site mentioned above to know these criteria.

### 6.0 Submission of Bids

- 6.1 All bids must be submitted in accordance with the instructions to the Bidders on or before **12:00 Hours** on **03.07.2017** and the technical proposals will be opened in the portal.
- 6.2 All bids must be accompanied by a bid security amounting to **Rs. 3, 50, 000.00** in the form of Bank Guarantee. Bid security shall have to be valid for **30 days beyond the validity of Bid.**

- 7.1 The technical proposals will be opened in the portal at **14:00 Hours on 03. 07 .2017 (same date for submission of Bid)** in the presence of bidders or their representatives who choose to attend.
- 7.2 AEGCL reserves the right to cancel/withdraw the invitation for Bids without assigning any reason & shall bear no liability whatsoever consequent upon such a decision.
- 7.3 Only those bidders whose Technical Bid is found substantially responsive and acceptable to the requirements of the Bidding Documents shall be considered for opening of Price Bid (price proposal). The date and time of opening of Price Bid shall be communicated to those bidders whose bids are qualified for opening.

#### 8.0 SPECIAL NOTE TO BIDDERS:

- 8.1 Bidder must create user ID in the web portal <a href="https://aegcl.etenders.in">https://aegcl.etenders.in</a> in order to participate in the e-tender.
- 8.2 A Bidder will be required to Encrypt and Sign online bid using their own Digital Signature Certificate (Class-II or higher with both Signing and Encryption Certificates). Prospective Bidders must procure DSC before participating in the tenders or in order to login into the portal.
- 8.3 A Bidder must download the Bidding Documents from the mentioned portal and both Technical & Price bid must be submitted through <u>online mode only</u> along with all scanned copy supporting documents (suggested scan at 150 dpi in PDF with a file size upto 10MB). The documents should be duly signed, scanned and uploaded with proper name. However, AEGCL may ask bidder to submit hard copies of GTP, Drawing, Manufacturer authorization of the major items and any other documents if deemed necessary.
